

Working Plan of the Slovak Accreditation Agency for Higher Education for 2024 with an outlook to 2025

WORKING PLAN OF THE SLOVAK ACCREDITATION AGENCY FOR HIGHER EDUCATION FOR 2024 WITH AN OUTLOOK TO 2025

On 20 June 2024, the Executive Board of the Slovak Accreditation Agency for Higher Education (hereinafter referred to as "the Executive Board") approved, pursuant to Art. 3 par. 3 and Art. 5 par. 5 of Internal Regulation No. 1/2022 internal quality assurance system of SAAHE's activities, this working plan of the Slovak Accreditation Agency for Higher Education for 2024 with an outlook to 2025 (hereinafter referred to as "the working plan").

Background and priorities

The working plan is based on the strategic areas and objectives identified in the Development Strategy of the Slovak Accreditation Agency for Higher Education for the years 2022-2027. It follows and builds on the previous working plan, which was approved by the Executive Board on 9 May 2023 and evaluated in the Evaluation of the Internal System of the Slovak Accreditation Agency for Higher Education 2023, which was approved by the Executive Board at its meeting on 20 June 2024. The working plan also takes into account the conclusions of the ENQA evaluation report, which was prepared as part of the external assessment of SAAHE and published on 20 September 2023.

In the strategic area of **accreditation activities**, the priority will be to reflect the conclusions of the assessment of compliance of the internal systems of higher education institutions and their implementation with standards. After completing all assessments and evaluating feedback from stakeholders, the Agency plans to present its findings at events and in an upcoming analytical report. The Agency will also gradually implement the recommendations of the ENQA Expert Panel and anticipates the possible optimisation of its rules and procedures.

In the strategic area of **international cooperation**, the Agency, already a full member of ENQA and registered in EQAR, intends to actively participate in the programmes and projects of these organisations. The successful completion of the decision-making process on the inclusion of SAAHE in the WFME database also remains a priority. The involvement of foreign reviewers in review panels will continue to be a priority in the field of international cooperation and internationalisation of the Agency.

In the strategic area of **culture of quality,** the Agency will carefully analyse the system of higher education institutions in the Slovak Republic, based on the evaluation reports of review panels, feedback, but also on the results of another survey of satisfaction of PhD students.

In addition to tasks reflecting the Agency's strategic goals, the working plan also includes other tasks resulting from the Agency's current internal needs and input from the external environment. These are listed in the fourth area of **other priorities**, which mainly include the issue of cybersecurity of information systems and its development into the Agency's rules and procedures.

The working plan shall be specified by the Agency into operational tasks, which shall be identified, controlled and monitored at weekly working meetings of the Chairman of the

Executive Board with the heads of departments/units and persons responsible for their implementation.
